Remember that your main goal for this paper is to set, explore, and back up your own argument. Simply referring to the articles and other texts is not your goal. Argue. Argue. Don't be afraid to qualify your argument.

#### **APA Lead ins:**

- 1. Lead in, "quote," (Coote, 2015).
- 2. As Coote (2015) claims, "quote."
- 3. Lead in, "quote" (as cited in Coote, 2015).

Lead In = your introduction to the quoted material.

## Examples:

Examples of improvements in 3-D technology continue to amaze us including the story of "a Utah boy's life [that] was saved last year by a 33-D printed plastic splint that propped open his windpipe" (Weintraub, 2015).

As Salzberg (2014) argues, "...They are manipulating viruses to give them new (and very dangerous) functions."

The new flexibility and "the ability to physically move those segments is huge," (as cited in Weintraub, 2015).
